Request

- i) Please can you let me know the number and location of regulated abattoirs presently operating in Great Britain authorised to slaughter horses for use in human food products?
- ii) Can you also please tell me how horses destined for slaughter, for the same end product overseas, are regulated and recorded here? What is the data trail?

Response

I will answer your questions in the order in which you have asked them.

i) Please find below the table highlighting those abattoirs which are approved to slaughter horses. Please note that this information is available in the public domain. For future reference you can access this information at http://www.food.gov.uk/enforcement/sectorrules/meatplantsprems/meatpremlicence you would then need to choose the list of establishments for meat of domestic ungulates and choose the spreadsheet related to the country you are interested in.

To be aware there are no establishments in Wales or Scotland.

Please note that you have specified in your request those "abattoirs presently operating in Great Britain authorised to slaughter horses for use in human food products". There is a presumption that any horse arriving at one of the above approved abattoirs will enter the food chain unless the Official Veterinarian deems it not fit for human consumption in which case the animal would then be disposed of in the appropriate way.

ii) In relation to your second question I note you have not specified whether you are referring to the regulation of live horses in the UK, the export of live horses or the export of horsemeat. The regulation of live horses in the UK, through the horse passport system, is Defra's area of responsibility. The arrangements for the export of live horses to third countries are the responsibility of the Animal and Plant Health Agency (APHA).

The requirements for the exports of meat to a third country will differ by country and the product being exported, but APHA are responsible for issuing the appropriate Export Health Certificates where formal arrangements have been agreed between

Defra and the authorities in the third country. Trade to countries within the European Union is considered to be intra-Community trade and, as such, there is free movement of goods. Products must meet EU requirements although they may be subject to customs and national checks. As such, we advise UK exporters to contact the authorities in the destination country to check if there are any specific restrictions before they attempt to export. I would therefore suggest that, depending on whether your query relates to live horse exports or the export certification of meat, you contact the relevant department responsible.
