Unsatisfactory results relating to fish species identification

In response to a Freedom of Information request, the FSA has published details of DNA speciation tests carried out by local authorities on meat and fish products, where the results were unsatisfactory.

In 2013 local authorities carried out 1250 tests on 768 samples of fish products; of these, 26 samples came back as unsatisfactory.

The table below provides a summary of the results of the samples taken of fish products which came back as unsatisfactory.
